RE: A proposed zone change and concept plan for a proposed 80-lot subdivision called Santaquin Estates which is located at approximately Main Street and 900 E. which encompasses the following parcel numbers; 32:040:0012, 32:040:0001, 32:004:0147.

HEARING TIME AND LOCATION:

Notice is hereby given that the Santaquin City Planning Commission will be holding a public hearing at approximately 7:00 P.M. on Tuesday October 26, 2021, the meeting will be held in person and online.

THE PROPOSAL:

Flagship Homes is proposing an 80-lot subdivision (79 residential and 1 commercial) located at approximately Main Street and 900 E. which encompasses the following parcel numbers; 32:040:0012, 32:040:0001, 32:004:0147. The subdivision is located within the R-10 Zone. It is proposed that the property be rezoned to Planned Unit Development (PUD) and Interchange Commercial (C-1). This proposal is a modified concept plan which incorporates the feedback that the applicant received from the previous subdivision concept plan review for this property.

HEARING PURPOSE:

The hearing is an open meeting in which residents will have the opportunity to voice concerns or ask questions about the proposal. Input received during the public hearing will help the Planning Commission understand potential impacts. If the impacts can be appropriately mitigated, the Planning Commission may recommend conditions to do so. The proposed plan must be approved if the plan complies with Santaquin City Code. This is the only public hearing that will be held on this request.
