## **ORDINANCE NO. 02-01-2015**

AN ORDINANCE AMENDING THE ANIMAL RIGHTS PROVISIONS OF THE SANTAQUIN CITY CODE, PROVIDING FOR CODIFICATION, CORRECTION OF SCRIVENER'S ERRORS, SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS, the City of Santaquin is a fifth class city of the state of Utah; and

**WHEREAS**, cities in the state of Utah are authorized to enact ordinances in order to promote and protect the health safety and welfare of the community; and

**WHEREAS**, the Santaquin City Council has previously adopted ordinance regarding the regulation of animals in the City; and

**WHEREAS**, the Council finds that public health, safety and welfare will be enhanced by amending the City Code to expand, redefine and clarify certain obligations of persons owning or keeping animals in the City and the conduct constituting violation of the City Code.

**NOW THEREFORE, BE IT ORDAINED** BY THE CITY COUNCIL OF THE CITY OF SANTAQUIN, UTAH, AS FOLLOWS:

1. **Section I.** Amendments. Section 5-2-8 of the Santaquin City Code are hereby modified as provided below: (Underlined text is added, stricken text is deleted)

## 5-2-8: ANIMALS AT LARGE:

No <u>chickens</u>, <u>fowl</u>, cattle, horses, mules, sheep, goats, llamas, or swine <u>or other animals</u> shall be allowed to run at large or to be herded, picketed, or staked out upon any street, sidewalk, or other public place within the limits of the city, and all such animals so found may be impounded.

**Section II.** Contrary Provisions Repealed. Any and all other provisions of the Santaquin City Code that are contrary to the provisions of this Ordinance are hereby repealed.

**Section III**. <u>Codification, Inclusion in the Code, and Scrivener's Errors.</u> It is the intent of the City Council that the provisions of this ordinance be made part of the Santaquin City Code as adopted, that sections of this ordinance may be re-numbered or relettered, and that the word ordinance may be changed to section, chapter, or other such appropriate word or phrase in order to accomplish such intent regardless of whether such inclusion in a code is accomplished. Sections of the ordinance may be re-

numbered or re-lettered. Typographical errors which do not affect the intent of this ordinance may be authorized by the City without need of public hearing by its filing a corrected or re-codified copy of the same with the City Recorder.

**Section IV**. <u>Severability.</u> If any section, phrase, sentence, or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

**Section V**. Posting and Effective Date. Prior to 5:00 p.m. on, the City Recorder shall: (a) deposit a copy of this ordinance in the official records of the City; and (b) post a copy of this ordinance in three places within the City. This ordinance shall become effective at 5:00 p.m. on
