## **Ordinance 4-01-2015**

AN ORDINANCE AMENDING CERTAIN PORTIONS OF THE SANTAQUIN CITY CODE TO RESTRICT PARKING OF VEHICLES AND OTHER OBSTRUCTIONS ALONG PARK STRIPS, PROVIDING FOR CODIFICATION, INCLUSION IN THE CODE, CORRECTION OF SCRIVENER'S ERRORS, SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS, the City of Santaquin is a fifth class city of the state of Utah; and

**WHEREAS**, cities in the state of Utah are authorized by the Legislature to regulate the use of streets, alleys, avenues, sidewalks, crosswalks, parks and public grounds, and prevent and remove obstructions and encroachments thereon; and

**WHEREAS**, the City Council finds that the proposed amendment will promote the health, safety and welfare of the residents of Santaquin City.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF SANTAQUIN, UTAH, AS FOLLOWS:

#### Section I.

Santaquin City Code, Section 7-1-5 Obstructions In Streets Or Public Ways is hereby amended as follows: (underlined text is added, stricken text is to be deleted)

#### 7-1-5: OBSTRUCTIONS IN STREETS OR PUBLIC WAYS:

It shall be unlawful for any person owning, occupying or having control of any premises to place, or permit to be placed upon or in the sidewalk, <u>planter strip</u>, parking area, gutter, or on the half of the street next to such premises:

- A. Refuse: Any broken ware, glass, filth, rubbish, sweepings, refuse matter, ice, snow, water, garbage, ashes, tin cans or other like substances.
- B. Building or Yard Materials: Any lumber, wood boxes, fencing, building material, dead trees, tree stumps, or any other thing which shall obstruct such public street, gutter, <u>planter strip</u>, parking area or sidewalk, or any part thereof, except as expressly authorized by ordinance, without the permission of the city council.
- C. Permanent or Temporary Obstructions: Any permanent or temporary structure, mechanism, device, vehicle, or other thing of any kind or character except trees planted pursuant to the provisions of applicable ordinances.

**Section II.** Contrary Provisions Repealed. Any and all other provisions of the Santaquin City Code that are contrary to the provisions of this Ordinance are hereby repealed.

**Section III.** Codification, Inclusion in the Code, and Scrivener's Errors. It is the intent of the City Council that the provisions of this ordinance be made part of the Santaquin City Code as adopted, that sections of this ordinance may be re-numbered or re-lettered, and that the word

ordinance may be changed to section, chapter, or other such appropriate word or phrase in order to accomplish such intent regardless of whether such inclusion in a code is accomplished. Sections of the ordinance may be re-numbered or re-lettered. Typographical errors which do not affect the intent of this ordinance may be authorized by the City without need of public hearing by its filing a corrected or re-codified copy of the same with the City Recorder.

**Section IV**. Severability. If any section, phrase, sentence, or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

**Section V**. <u>Posting and Effective Date.</u> Prior to 5:00 p.m. on, the City Recorder shall: (a) deposit a copy of this ordinance in the official records of the City; and (b) post a copy of this ordinance in three places within the City. This ordinance shall become effective at 5:00 p.m. on April 2, 2015
