ORDINANCE NO. 06-02-2017

AN ORDINANCE AMENDING 'COMMUNITY DEVELOPMENT DEPARTMENT – DEPARTMENT COMPOSITION (SECTION 1-13-3)' OF THE SANTAQUIN CITY CODE, PROVIDING FOR CODIFICATION, CORRECTION OF SCRIVENER'S ERRORS, SEVERABILITY, AND AN EFFECTIVE DATE.

WHEREAS, the City of Santaquin is a fourth class city of the State of Utah; and

WHEREAS, the Santaquin City Council has previously adopted an ordinance regarding the Community Development Department; and

WHEREAS, the Santaquin City Council now desires now to amend the language of Section 1-13-3: Department Composition as a result of personnel and organizational changes;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SANTAQUIN, UTAH, TO MODIFY TITLE I CHAPTER XIII SECTION III AS FOLLOWS:

Section I.

1-13-3: DEPARTMENT COMPOSITION:

The community development department shall include consist of the city manager's office, the building office, consisting of the city building official, building inspectors, infrastructure inspectors, commercial inspectors, and public works inspectors; the planning office consisting of the city planner(s), and the city zoning administrator; the engineering office; the parks and recreation department; and all supporting staff and personnel, whose duties and powers are established elsewhere within this code. The community development department shall work in partnership with the engineering office with regard to shared personnel and expenses. The community development department shall also include the management of other municipal departments as assigned by the city manager.

Section II. <u>Contrary Provisions Repealed.</u> Any and all other provisions of the Santaquin City Code that are contrary to the provisions of this Ordinance are hereby repealed.

Section III. <u>Codification, Inclusion in the Code, and Scrivener's Errors.</u> It is the intent of the City Council that the provisions of this ordinance be made part of the Santaquin City Code as adopted, that sections of this ordinance may be re-numbered or re-lettered, and that the word ordinance may be changed to section, chapter, or other such appropriate word or phrase in order to accomplish such intent regardless of whether such inclusion in a code is accomplished.

Sections of the ordinance may be re-numbered or re-lettered. Typographical errors which do not affect the intent of this ordinance may be authorized by the City without need of public hearing by its filing a corrected or re-codified copy of the same with the City Recorder.

Section IV. Severability. If any section, phrase, sentence, or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

Section V. <u>Posting and Effective Date.</u> Prior to 5:00 p.m. on June 22, 2017, the City Recorder shall: (a) deposit a copy of this ordinance in the official records of the City; and (b) post a copy of this ordinance in three places within the City. This ordinance shall become effective at 5:00 p.m. on June 22, 2017.
