ORDINANCE NO. 02-04-2018

AN ORDINANCE AMENDING THE ZONING MAP OF SANTAQUIN CITY TO INCLUDE THE OLSON GREENHOUSE III ADDITION ANNEXATION AREA LOCATED ADJACENT TO THE CURRENT CORPORATE BOUNDARIES OF SANTAQUIN CITY, UTAH

WHEREAS, on October 13, 2017, Summit Creek Nursery LLC which owns certain real property adjacent to the City of Santaquin (the "Petitioners"), petitioned to annex the real property described in Exhibit A (the "Property") to the City; and

WHEREAS, the Petitioner owns the majority of the privately owned real property within the area proposed for annexation; and

WHEREAS, all Affected Entities have received notice of the proposed annexation; and

WHEREAS, on January 3, 2018, the Santaquin City Council held a public hearing to receive public input concerning the proposed annexation, which public hearing was properly scheduled and noticed in accordance with Utah law; and

WHEREAS, the area proposed for annexation lies within the City's current Annexation Policy Plan; and

WHEREAS, on January 3, 2018 the City Council adopted Ordinance No. 01-01-2018 for the purpose of amending the Official Zone Map of Santaquin City to include the Property and subsequently forwarded a Notice of Impending Boundary Action to the Office of the Lt. Governor of the state of Utah to complete the annexation; and

WHEREAS, the Office of the Lt. Governor has informed the City that the Notice of Impending Boundary Action has been rejected because said notice was incomplete and was not received within the time required by law; and

WHEREAS, Santaquin City, Utah desires to complete the statutory process to amend the Official Zone Map of Santaquin City to include the Property within the City's regulatory boundary;

NOW, THEREFORE BE IT ORDAINED by the City Council of Santaquin City, Utah as follows:

SECTION 1. Official Zone Map Amended. The Official Zone Map of Santaquin City as adopted by Section 10-7-2 of the Santaquin City Code is hereby amended to include the annexed real property as depicted in Exhibit B.

SECTION 2. Designation. The amended area shall be zoned Agriculture (Ag) as depicted on the zoning map, a copy of which is attached hereto as Exhibit B and incorporated herein by reference.

The Mayor is hereby authorized to execute SECTION 3. Execution of Documents. AMENDED ARTICLES OF INCORPORATION OF THE CITY OF SANTAQUIN and a certification of the Santaguin City Council that the legal procedures for annexation have been completed.

SECTION 4. Posting. A copy of this ordinance shall be deposited in the office of the Santaquin City Recorder, and on before 5:00 p.m. on February 22, 2018, the Santaquin City Recorder shall certify that this Ordinance has been posted in three public places within the municipality, as provided in Utah Code Annotated § 10-3-711(1).

SECTION 5. Contrary Provisions of Ordinance 01-01-2018 Repealed. All provisions of Ordinance 01-01-2018 found to be contrary to the provisions of this Ordinance 02-04-2018 are hereby repealed.

SECTION 6. Effective Date. This Ordinance shall take effect at 5:00 p.m. on February 22, 2018, and the described Annexation shall be effective upon the certification of the Utah Lt. Governor.




